

GENERAL SHAREHOLDERS' MEETING BBVA COLOMBIA MARCH 26, 2025

At the regular meeting of the General Shareholders' Meeting held on March 26, 2025, the resignations of Directors Carlos Eduardo Caballero Argáez and Luis Julián Martín Carranza Ugarte, who served as Chairman and Member of the Board of Directors of BBVA Colombia, respectively, were received. Both resignations were submitted for personal reasons, not arising from matters of material relevance to the entity.

Additionally, following the approval of the amendment to Article 26 of the Bylaws, voted favorably by the Meeting, the Board of Directors of BBVA Colombia will be composed of seven members, implying a reduction in the number of members. Therefore, there will be no new appointments to replace the outgoing members.
